Dear City Council Members,

I moved to Santa Rosa in 1990 to take a job as a Santa Rosa Police Officer. I had already worked in another agency, but came here because of the reputation of the department and to live in this beautiful county. I live in the city and raised my children here.

In my twenty-five years with SRPD, staffing levels went up and down. Every time staffing levels dipped, services were cut, response times were longer, morale was poor, and the quality of service suffered. Your department staff wants to do a good job for the community, but they get frustrated with the increased demands with less staff. Overtime also leads to burnout and affects the mental health of the employees.

As a resident of Santa Rosa, I have many concerns about decreased staffing, both civilian and sworn. There's been significant annexation and an increase in calls for service. The fires showed us how a massive incident can require significant personnel. I know there are fewer dispatchers to answer 911 and fewer officers to respond to calls. As a homeowner and taxpayer, I am asking that an increase in public safety staffing be made a budgeting priority.



I am a Sonoma County resident who frequents the Railroad Square area restaurants and activities. I urge you to fund the proposed 2 positions in the Downtown Enforcement Team (bike patrol) so that there is 7 day coverage of the downtown area. This is an important service to address narcotics, misdemeanor crimes, and disturbances in the downtown area. Bike units have proven to be very cost effective and an important part of community policing.

I frequently take SMART from the Rohnert Park area to Downtown as Santa Rosa has more food and social options. I am a single woman in my 50s with some mobility issues, I really appreciate having the SMART downtown station and walkable entertainment options.

I've worked for Sonoma County in Behavioral Health and the Sheriff's Office. I've also worked for L.A. City and the LAPD in policy and operations. I have read the police services section of the proposed FY 23-24 budget and skimmed the housing section. I believe in professional, progressive law enforcement services and multi-disciplinary collaboration. I understand that police services comprise a large portion of any city budget and there can be some public outcry to redirect these funds.

I think it is extremely important to address all levels of crime, quality of life, and public substance use/dealing (not just media profile issues). Sonoma County is adding a significant amount of high-density housing, some of it to homeless and transitional housing. We MUST add services to support this density increase. With high-density urban housing comes additional need for all services, including enforcement. Many are experiencing homelessness because of hard financial times, but others are service resistant and some unfortunately have challenging/unsafe behaviors that, a decade years ago, would have been contained in a custody setting. Now contact with police is sometimes the first step toward a person getting linked to other services in behavioral health or substance treatment.

Many substance related crimes (like possession of fentanyl and other problem narcotics) are now misdemeanors, and the general public is experiencing the effects of a greater number of service resistant individuals living in downtown Santa Rosa and parts of my town of Rohnert Park. It's great to offer treatment, but we still NEED enforcement of problem behaviors that impact and cause safety and health related issues to the rest of the public, other residents, and commercial businesses.

We need community policing not just in principle, but to support the very tax base that funds so many of our programs. I fully support the crisis inRESPONSE team too, because we need collaboration and expertise to continue to make Sonoma County a wonderful place to live.
