#### Mission

- Protect the health and safety of people and animals.
- Investigate and prosecute animal cruelty and neglect.
- Educate the public about responsible domestic animal ownership.
- Reduce pet overpopulation through spay/neuter programs.
- Provide a safe environment for animals in need.
- Place adoptable animals into caring homes.

### Day to Day Service Updates

- Contracted with DocuPet in 2022 for dog and cat licensing
- Increased lobby hours from 12:00-5:30 to 10:00 to 5:00
- Created a separate phone queue for dispatch officer line
- Five low or no-cost spay/neuter programs
- Three trailers for emergency response, including heating and cooling centers, and natural disasters

### Wohlford Consulting Fee Study Goals

- Determine the full cost of the services provided by Animal Services
- Balance revenues and/or cost-recovery
- Improve fairness and equity
- Ensure compliance with state law
- Completed May 2023

### Reasons for proposed fee changes

- Determination of actual costs per fee type.
- Changes to SCAS business and fee structures.
- The development of new fees to better reflect the services provided to the public.
