

**FIRST AMENDMENT
TO AGREEMENT NUMBER F002154 WITH SONIC, LLC**

This First Amendment to Agreement number F002154, dated April 25, 2021 ("Agreement"), is made as of this _____ day of _____, 2024, by and between the City of Santa Rosa, a municipal corporation ("Customer"), and Sonic, LLC, dba Sonic ("Sonic").

RECITALS

- A. City and Consultant entered into the Agreement for Consultant to provide Internet connectivity for citywide staff and on-site guests, as well as free high speed Wi-Fi service to our residents and visitors in the Courthouse Square and Railroad Square areas of our Downtown
- B. City and Consultant now desire to amend the Agreement for the purpose of extending for another (5) five year term through April 24, 2029, adding an option to extend the Agreement for an additional (5) five years, increasing compensation, and adding a \$10,000 contingency.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Scope of Services

Service Agreement dated May 10, 2020 to the Agreement is supplemented by Service Agreement dated February 15, 2024, which is attached hereto as Exhibit A-1.

2. Compensation

The Agreement is amended to increase the compensation payable to Sonic by \$223,840.00 and add contingency in the amount of \$10,000. Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of three hundred thirteen thousand, forty dollars and no cents (\$313,040.00). The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number 350304-5320.

3. Time of Performance

The Agreement is extended for (5) five years, through April 24, 2029, with an option to extend for an additional (5) years through April 24, 2034.

All other terms of the Agreement shall remain in full force and effect.
