FIRST AMENDMENT TO AGREEMENT FOR ACCEPTANCE OF BIOSOLIDS AND LAND APPLICATION NUMBER F002459 WITH GILARDI & JACOBSEN AG SERVICES, INC.

This First Amendment to Agreement Number F002459, dated April 7, 2022 ("Agreement") is made as of this _____ day of _____, 2023, by and between the City of Santa Rosa, a municipal corporation ("CITY"), and Gilardi & Jacobsen Ag Services, Inc., a California corporation ("USER").

RECITALS

- A. CITY and USER entered into the Agreement for CITY to provide Biosolids to USER for spreading, incorporating and herbicide application on USER's Farm Lands.
- B. CITY and USER now desire to amend the Agreement for the purpose of increasing the Rates payable to USER for performance of services and increasing compensation payable under the Agreement by \$94,000.00 to account for the increase in the San Francisco area Consumer Price Index for All Urban Consumers of 4.9%, determined in December 2022.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Exhibit B to the Agreement is hereby replaced with Exhibit B-1, which is attached to this First Amendment.
- 2. Section 3 of the Agreement is amended to increase the compensation payable to USER under the Agreement by \$94,000.00 (ninety-four thousand dollars) and the second paragraph of Section 3.a. is amended to read as follows:

"The total maximum compensation to be paid hereunder for the satisfactory performance and completion of all services shall not exceed \$208,418.95 (two hundred and eight thousand four hundred and eighteen dollars and ninety-five cents) as determined for each of the Farms included in Exhibit B-1."

All other terms of the Agreement shall remain in full force and effect.
