I'm here to speak about emails the Council received in past months from members of the Santa Rosa Manufactured-home Owners Assn.

I know those emails expressed Thanks for your past actions, first, revising the Rent Control Ordinance, and second the work the Council and staff had to do, when it was pointed out that 5 parks were left out of the revised RCO.
