

CITY'S ZERO WASTE GOAL

- > Reduce landfill disposal to less than one pound per person per day of franchised waste.
- Achieve at least 75% diversion of franchise waste from landfill disposal by 2030

GOAL	2020	2025	2030	2040
Per Capita Disposal based on Recology Tonnage (pounds per person per day)	2.8	1.8	1.0	< 1.0
Diversion Rate	40%	55%	75%	75%+

ZERO WASTE FOOD WARE ORDINANCE

- Effective January 2022
 - Bans food ware containing polystyrene foam and PFAS
 - Food Ware Accessories provided upon request ONLY
 - Dine-in accommodations may only offer reusable food ware & accessories
 - Dine-in facilities must provide three bin waste streams
- Maintain partnerships with Recology, Zero Waste Sonoma, and Cascadia
- Learn from other jurisdictions
- Outreach



MANDATORY RECYCLING & COMPOST PROGRAMS

- AB341= mandatory commercial recycling
 - 99% compliant
- AB1826=mandatory commercial organics recycling
 - 99% compliant
- SB1383= jurisdictions required to provide all residents and businesses with organic waste collection services.
 - 98% compliant



CONSTRUCTION & DEMOLITION ORDINANCE

- Proper disposal and tracking of construction materials
- Reviewing Model C&D Ordinance developed by Zero Waste Sonoma
- Green Halo tracking/reporting software soon to be implemented



TARGETED TECHNICAL ASSISTANCE

- Increase diversion rates, reduce contamination and achieve full compliance with regulations
- Focus on commercial, multi-family dwellings, and schools
- Working with Zero Waste Sonoma and Cascadia to offer technical assistance (project timeline January 2024-April 2025)
 - High waste generators
 - SB1383 food recovery implementation
 - Zero Waste Food Ware Ordinance compliance



ZERO WASTE CULTURE CHANGE

- Lead by example
- Support local reuse/repair fairs
- Focus on City events
- Maintain partnerships with Recology, Zero Waste Sonoma, and the community
- Outreach

Action 6.2.2. Encourage local businesses to reduce amounts of packaging used.	✓ Targeted Technical Assistance

Action 6.2.4. ACCOMPLISHMENTS

Zero Waste Sonoma Efforts (Jul 2022-June 2023)

- Compost giveaway events: 10 (400 cubic yards)
- Single-use propane cylinder collection sites: 3 locations
- HHW collection events: 12 (average 76 participants per event)
- E-waste collection events: 5 (29,774 lbs of e-waste, 51,296 lbs of universal waste)
- Mattress collection events: 2 (204 collected)
- Total events: 69 (218 hours of outreach)

Recology Efforts (Jan-Dec 2023)

- Site visits/audits= 1,060
- Presentations/trainings= 176
- New compost services= 125
- Increase compost services = 36
- Increase recycle services= 26
- New, upgraded Materials Recovery Facility (Nov. 2023)
 - Processing 400 tons per day
 - 85% recovery
