Hi Kristinae,

This email is my public comment regarding the above referenced project for the meeting to be held 5/11/2023 at 4:30PM.

I am against expansion of the current 7-11 because of the traffic hazard it would exacerbate. The current 7-11 already unreasonably snarls traffic. The expanded store will only make the problem worse. As a neighbor residing at 4733 Startbuck Ave (just a few blocks away), here is what I regularly observe:

- Traffic heading East on Highway 12 will seek to turn left on Middle Rincon Road to head into their residences in Rincon Valley.
- The traffic will line up in the left turning lane waiting for the left turn arrow to flash green.
- Opposing Traffic will be lined up along Middle Rincon on the 7-11 side of the street, blocking the 7-11 driveway entrance.
- The above mentioned left turn arrow on Highway 12 will open and cars will rush to make the arrow.
- All-of-a-sudden, one of the left-turning cars will stop, wanting to turn left into 7-11.
- Because of the backed-up traffic from cars on Middle Rincon in front of 7-11, there will be no way for the 7-11 entering car to turn in.
- This will create a log-jam, as left turning cars from Highway 12 will dangerously screech to a stop behind the 7-11 customer trying but failing to turn left.
- Worse, left turning cars will back up into the intersection past the time of the light.
- The log-jam will block cars in all direction until somehow, the 7-11 customer car finds a way into the 7-11 parking lot.

With a bigger store, the traffic log-jam problem from left-turning 7-11 customers will only get worse. Therefore, I appose the expansion of 7-11 at Highway 12 and Middle Rincon.
